Jo Ann Freiberg, Ph.D will present on "Working Collaboratively With Schools to Diminish Bullying: A Partnership Approach." Jo Ann Freiberg is an Educational Consultant with the Connecticut State Department of Education working with the Bureau of Accountability and Improvement. She manages the wide arena of Bullying, Improving School Climate and Character Education for Connecticut.
